Minutes of the 2nd Public Hearing of the Board of Trustees

August 16, 2018

The Board of Trustees of the Texas Southmost College District convened in open session on August 16, 2018, at 5:30 p.m., in the Gorgas Board Room at Texas Southmost College. Board Members present were Ms. Adela Garza, Chair; Mr. Ruben Herrera, Secretary; Dr. Tony Zavaleta, Mr. Art Rendon, Ms. Eva Alejandro and Mr. J.J. De Leon, Jr. Board member not present was Mr. Trey Mendez, Vice Chair. Also present was Dr. Jesús Roberto Rodríguez, President of Texas Southmost College.

1. Call to Order

The Public Hearing was called to order by Chair, Adela Garza at 5:31 pm.

2. Pledges of Allegiance

Dr. Tony Zavaleta led the United States Pledge of Allegiance and the Texas Pledge of Allegiance.

3. Public Hearing on Proposed 2018 Ad Valorem Tax Rate for Texas Southmost College District

Ms. Garza stated that this is the 2nd Public Hearing to give the taxpayers an opportunity to express their views on the Board's proposed tax rate. The Board is proposing a Maintenance & Operations Tax Rate of \$0.115248 and a Debt Tax Rate of \$0.047159 for a Total Tax Rate of \$0.162407 per \$100 valuation. Ms. Garza stated that this rate is the same as the current rate and will not increase taxes for a property if its appraised value remained the same.

The notice of proposed increase was published in the newspapers on August 6, 2018. Ms. Garza open the floor for any speakers. There were no speakers.

Ms. Garza stated that the Regular Board meeting to vote on the tax rate is scheduled for Thursday, August 23, 2018 at 5:30 p.m. in the Gorgas Board Room.

4. Adjournment

A motion to adjourn the Public Hearing was made by Mr. Herrera. The motion was seconded by Mr. De Leon, Jr. and carried unanimously. The meeting was adjourned at 5:36 p.m.
